At our board meeting on January 8th, three members renewed their membership bringing our renewals for 2019 to 23 of our 101 members at the close of 2018. We also have 6 Active Duty officers who will be continued as members of the Chapter.

MOAA National had a 2018 retention incentive of \$250 for each chapter that retained 80% or more of its 2017 members, not counting those who have moved away from the local area or die; and not counting those who are not members of MOAA at the National level. I believe we should qualify for that award. It is not clear if that incentive will be continued or be modified for 2019.

We need to continue recruiting to maintain the vitality of the Chapter. Each and every member can contribute to our recruiting effort! If you know someone eligible for MOAA membership, please invite them to our next General Meeting, and/or ask them to submit a Chapter membership

A short notice, showing up in the daily news cycle once, was a press release from the Department of Defense in early December 2018. It announced that individuals with green cards could now serve in the military forces. This odd piece of isolated news fits into a much bigger picture and problem. military services were having finding enough recruits for 2019. The following numbers are rounded but are in the right magnitudes. The military services need approximately 250,000 men and women recruits to meet their demands for 2019. The pool from which they are to draw 18 to 26-year-old recruits is about 500,000. Unfortunately, about ½ of the pool is ineligible due to academic or physical problems. Surveys found that 50 percent of the remaining 250,000 possible recruits are in families that discourage serving in the military. Thus the December 2018 notice enlarging the pool.

Past President's Note

In 1981, while stationed at Yokota Air Base in Japan, I participated in an Engineering Conference put on by the U.S. Army Corps of Engineers in Seoul, South Korea. Part of the event was to visit many of the Army outposts south of the [Demilitarized Zone \(DMZ\)](#), along the 38th Parallel, the truce line from the Korean War. The DMZ is a 160 mile, 2 ½ mile wide, strip of land which separates the Republic of Korea (ROK) from Communist North Korea (NOKO). It is considered the most heavily guarded place on earth, with millions of land mines and barbed wire fencing enclosing the land.

While there, a visit was made to the Village of Panmunjom, where armistice talks and other matters take place. To be allowed to visit Panmunjom, one must sign a death waiver that if anything untoward happens, you are basically on your own. Also, while there, you must never point to something because that alone could spark an international incident. The village is guarded by the U.S. Army and ROK soldiers on the south side and NOKO soldiers on the north side. You

can enter the building in which a long table seats delegates from both sides. Technically, I have been in North Korea because I walked around the north side of the table which is theoretically bisected in the middle by the truce line. A NOKO guard observed me through a window while I was inside. Even though it has been 38 years, I have never forgotten the level of hate which the guard showed in his face. The DMZ keeps the two sides apart. It is not a place for the faint of heart. It began as a de facto international border since 1948 and is one of the most tense fronts in the Cold War.
